CLEARING THOSE HIGH HURDLES

2022 was a great year for High Hurdles in many ways. We overcame some “hurdles” early in the year but finished out strong. We had some injuries with horses over the winter that kept us busy, as well as continuing with volunteer and staff trainings, and keeping the horses happy.

In April, we had a new horse, Beau, donated to the program, and he has proven to be a wonderful asset for our riders. In August, we were able to purchase a pony, Rapunzel, to fill the role our long-time resident Dancer has retired from.

We had a total of 959 individual units of service to about 90 riders throughout the year. High Hurdles riding instructors and volunteers continue to collaborate on lesson planning and instruction while keeping safety measures at the forefront of our operations. They love watching the riders learn and grow, building physical strength, increasing their horsemanship skills, and having an enjoyable activity to take part in.

We were able to lift the mask requirement this year and have a more traditional show that allowed for as many family and friends as riders wanted to invite to come watch them this year. The show was an enjoyable time for all!

RESIDENTIAL REVERIE



Matt Klajbor realized a dream that many people share: to live in his own apartment.

There's nothing quite like the first time you sit on your couch, that you purchased, in your own living room, watching your favorite show on your TV. With help from some sasi staffers, Matt was able to do just that.

Matt moved into the Elliott Woods Apartment Complex in Orchard Park. He was able to receive a rent subsidy through sasi from the OPWDD Housing Subsidy Program, which provides monthly rental assistance to those who qualify. It also provides a transition stipend that can be used to purchase furniture, home items, and help pay for a security deposit.

"Without this funding, it may be more difficult for people to move out on their own, find housing they can afford, or furnish their home," said Kelly Cline, sasi's Director of Community Services.

Matt had previously lived with his parents. While it was a lifelong dream to one day have his own place, it was at the beginning of 2020, just before the start of the COVID-19 pandemic, that he started making actual plans for it. Matt received plenty of help from his parents, who worked with him on what living alone means and how to care both for himself and for an apartment. Matt is also part of the sasi Community Habilitation Program and with the help of Barb Feldman, Community Habilitation manager, Matt changed his address on his license. Matt and Barb also shop and cook together.

Matt admitted it was a little scary to live on his own at first, but he loves it.

"It's been a good experience," he said. "I have more freedom and more space."

sasi's mission to transform the lives of people with special needs means that the organization shares in Matt's success.

"It's been exciting watching Matt's transition into the apartments, from the initial tour to his lease signing to move-in day," Cline said. "I'm so glad I got to be a part of that process and watch Matt's confidence grow as he made his apartment his own."

So what does Matt say is the best part about living alone?

"I would have to say staying up late!"



MAKING MIRACLES FOR 25 YEARS



It is with joy and pride that we celebrate our first 25 years of success and wonderful memories.

Almost 25 years ago, Moving Miracles Dance Studio was established through a coincidental meeting of dance teachers in an 84 Lumber Hardware Store. Unbeknownst for many years, a universal shift was simultaneously occurring among dance teachers in different corners of the country. Research papers reported dance educators were witnessing the profound effects music and dance had on awakening communication and learning pathways in people with different abilities.

Since September 1998, each drop of the needle has inspired passion within dancer and teacher. Moving Miracles' first community outreach was an appearance on the Variety Club Telethon, performing Annie's classic, "Hard Knock Life." We were so proud of those dancers then, and are happy to say that Jenna, Erica, and Ashley are still in studio every week.

"Who Let The Dogs Out" brings back memories and laughter, of when Stacey, Jessica, Elena and Carly sang through rehearsals never missing a beat. Stacey's parents, Ron and Diana Papa, of National Fire Adjustment Co., Inc. have been a driving force from the studio inception through every milestone. After 25 years, ballet dancers, Amy and Haley still have the most gorgeous and highest arches and pointed feet ever! Dance pioneers from 1999 Hillary, Denis, Laura and Kate (not to mention their parents) became the backbone of the dance studio.

2022 was a year of getting people back into program and re-establishing community partners. The Community Prevocational Program has gone back to working at Astronics Industry, volunteering at SPCA, food banks and senior centers, and helping with Mats for Mission. The program also has internships at McDonalds, Green Zone, and Lime Lake Marina. Everyone is happy to be able to socialize with community members.



Along with that, our Group Day Habilitation Program has also increased community opportunities such as volunteering at the Botanical Gardens and delivering flowers donated by Tops Markets to several local nursing homes. We have many fun and educational activities. Music is a big part of our day. At any of the day programs, you will frequently hear everyone laughing and singing!

sasi's Supported Work Program has new leadership with Director Bridgette Zittel and Team Leader Arian Anstett. In 2022, sasi had many referrals for students transitioning into the world of work. The department is working with four school districts to provide training and hands on experience. The people in this program are referred by ACCES-VR. We look forward to continued expansion of the Supported Work Department.
